Payments

We accept checks, wire transfer, ACH, and most major credit cards.

Drawings

Review all measurements and specifications for accuracy. Specific measurements and preferences must be noted on the signed drawings and are incumbent upon the purchaser. All intellectual property, including shop drawings, designs, and specifications created by Vintage Doors, remains the sole property of Vintage Doors Inc. Signatures are required on order summary, shop drawings, and terms & conditions along with payment.

Ordering

All orders are custom and once placed cannot be cancelled or returned. Payment in full is required unless deposit is explicitly stated. Once order documents are approved, some changes to the order may not be possible and all changes will incur a \$75 change order fee. Hardware purchases can be returned within 30 days of delivery with a 25% restocking fee; special hardware orders are non-returnable.

Shipping

In no event shall any product be delivered to the purchaser until the purchaser has paid the purchase price in full plus all taxes, shipping and any other charges related to the sale and delivery. Delivery locations must be tractor trailer accessible. Deliveries are to the curbside, and require an appointment, unloading assistance, customer inspection, and signature.

Any change to the provided delivery address at time of order may incur a \$25 change of address fee (plus any adjustment to shipping value). Multiple prehung door orders may be broken down for shipment and labeled for assembly. Lift gate deliveries are available.

Vintage Doors will notify client at time of shipment with delivery details, transit times and tracking numbers. If client delays shipment, \$15/day storage fees will apply. All packages must be signed for and inspected for damages at the time of delivery. Unsigned shipping invoices and undocumented damages upon delivery will render Vintage Doors Inc free from any claims and liability.

General Provisions

All transactions between the parties shall be governed and construed in accordance with the laws of the State of New York. Vintage Doors Inc and purchaser expressly agree that any dispute, controversy, or claim arising out of or relating to this Agreement, a breach thereof, or any Product delivered hereunder, shall be determined by a court of competent jurisdiction for the County of St. Lawrence State of New York.

In no event shall Vintage Doors Inc. be liable for any incidental, consequential, special, or indirect damages, including lost profits. The maximum liability of Vintage Doors Inc. shall be strictly limited to the purchase price of the specific product giving rise to the claim. Vintage Doors Inc. shall not be liable for any delay or failure to perform resulting from causes outside its reasonable control, including but not limited to natural disasters, labor strikes, supply chain interruptions, or government actions etc.
